Terminology

MAGI – Modified Adjusted Gross Income MAGI Medical Assistance Programs

- Health First Colorado Programs:
 - Child
 - Adult
 - · Caretaker Relative
 - Pregnant Women
- CHP+ Child Health Plan Plus
- Marketplace Financial Assistance

Advance Premium Tax Credit (APTC)

Financial Assistance paid directly to the insurance carrier throughout the coverage year

Cost Sharing Reduction (CSR)

Health plan with lower "out-of-pocket" expenses such as co-pays and deductibles

Federal Poverty Level (FPL)

A measure of income issued annually by the Department of Health and Human Services, and used to determine eligibility for certain programs and benefits

Colorado Benefit Management System (CBMS)

The electronic system and rules engine that determines households and eligibility

Household Members


The information for those not applying, but who live in the household and have a tax-filing, legal or biological relationship with those who are applying, needs to be included.




Example 1 - Divorced/Custody

- Sam & Julie are divorced
- They have 50/50 custody of Dylan
- Who do you include in the application?
- Who do you include in the application?




Example 2 – Undocumented

- Mateo & Velma live together and living with them are:
 - David and Sofia, their children
 - Lucas, Mateo's son
 - Maria, Velma's pregnant daughter
- Mateo and Velma are not married
- Mateo files taxes and claims Lucas, David, Sofia, and his sister Isabella (who lives in MX)
- Velma is undocumented
- Maria is documented
- Who do you include in the application, and why?



Example 3 – Residence

- Jasmine & Jordan are married and have 3 children: Mathew, Kiara and Trinity
- Jasmine's brother, Jayden, and mother,
 Celie live with her
- Mathew goes to college in another state
- Jordan works on oil rigs in other states
- Jasmine & Jordan file taxes jointly and claim their children and Celie, Jasmine's mother
- Who do you include in the application, and why?



Example 4 - Incarceration

- Marcus & Abigail are married and have three children: Jake, David, Kaitlin
- Abigail's mother, Pearl and her sister, Hannah, live with them
- Marcus is incarcerated
- Abigail files taxes as married filing jointly, and claims her mother and the four children
