Ed McMahon holds the Charles Fraser Chair on Sustainable Development at the Urban Land Institute in Washington, DC. Mr. McMahon is an attorney, community planner, lecturer, and author. As the Senior Fellow for Sustainable Development, McMahon leads ULI's worldwide efforts to conduct research and educational activities on environmentally sensitive development policies and practices. Before joining the Urban Land Institute in 2004, Ed McMahon spent 14 years as the Vice President and Director of Land Use Planning for The Conservation Fund in Arlington, Virginia. He is also the co-founder and former President of Scenic America, a national non-profit organization devoted to protecting America's scenic landscapes. He is the author or co-author of 15 books and over 200 articles. His books include: *Developing Sustainable Planned Communities*, *Green Infrastructure: Linking Landscapes and Communities*, *Balancing Nature and Commerce in Gateway Communities* and *Better Models for Development in Pennsylvania*. He also writes regularly for *Urban Land Magazine*, *Planning Commissioners Journal* and other periodicals. Over the past 20 years Mr. McMahon has drafted numerous local land use plans and ordinances. He has organized successful efforts to acquire and protect urban parkland, wilderness areas and other conservation properties.

McMahon serves on several boards and commissions including: the National Trust for Historic Preservation, Preservation Maryland and The Governors Institute for Community Design and the Orton Family Foundation.

McMahon has an M.A. in Urban Studies from the University of Alabama and a J.D. from Georgetown University Law School where he taught law and public policy from 1976-1985.

Kamuron Gurol

Kamuron has served as Assistant City Manager and Community Development Director for the City of Sammamish since 2005. Sammamish is a new city (incorporated 1999) that formed to gain greater control over local issues, especially growth and development challenges. His team has successfully navigated an innovative Town Center plan (using a hybrid of performance and traditional zoning tools) and new Shoreline Master Program (using an incentive-based strategy to improve habitat while recognizing property rights) through the rough waters of public comment, planning commission review, state agency approval and city council adoption. Sammamish also received a 2009 Governor's Smart Community award for our over-the-counter permit approval process.

Prior to that, Kamuron worked as a corridor planning manager for the Washington state DOT Urban Planning Office, where he oversaw corridor improvement plans for several large state highways in the greater Seattle area. As director of the Kitsap County Department of Community Development, Kamuron was responsible for all aspects of community development department (building plan review and inspections, land use permits, long range planning and a CDBG grant program) serving about 250,000 residents. As manager of the Snohomish County Planning Division, he was responsible for successful policy development for the county comprehensive plan and various subarea plans, for planning policy issues with 20 cities, and for county GIS and demographic work products. He began his work in public administration, planning, environmental and natural resources with King County where he created a nationally-recognized transfer of development rights program.

Kamuron holds a Bachelor of Science degree in Geology from the University of Washington and a Master of Public Administration degree from the Kennedy School of Government at Harvard University.

Debbie Lou is the Program Analyst with Active Living Research (ALR), a national program of the Robert Wood Johnson Foundation that uses evidence to fight childhood obesity and create more physically active communities. Ms. Lou translates and disseminates research on how the social and built environments impact public health.

Ms. Lou engages with organizations across the nation to ensure that research can inform policy and practice to increase opportunities for physical activity, especially among minority and lower-income communities that are at highest risk for obesity.

Ms. Lou manages ALR's communication initiatives, including a bi-monthly newsletter, social media outreach, and a Dialogue for Health Web Forum series in partnership with the Public Health Institute. Ms. Lou is co-author of a research synthesis with Dr. Wendell Taylor titled "[Do All Children Have Places to be Active?](#)" This synthesis shows that lower-income people and racial and ethnic minorities often live in communities that discourage active living. She holds a PhD in Sociology from the University of California, Santa Barbara.

James A. Moore has over 20 years of experience in all aspects of Urban Redevelopment, Urban Design, and Community Planning. He joined HDR in 2000, as the company's National Community Design Principal, dividing his time among national projects, marketing new proposals, and helping develop initiatives in the areas of Real Estate Consulting, Transit-Oriented Development, and Sustainable Community Design. Since 2004, he has been the National Director of HDR's Community Planning & Urban Design business practice, overseeing 85 staff in a dozen offices. Dr. Moore has been the project principal on a number of notable HDR projects including the Destination Midtown Redevelopment Master Plan and the North Downtown (NoDo) Redevelopment Master Plan, both in Omaha NE, "Pinellas by Design," a unified economic development and physical redevelopment strategy for all of Pinellas County FL, the Albuquerque NM Transit-Oriented Development (TOD) Conceptual Design, and the 30th Street Sector Redevelopment Plan in Boise ID. His areas of expertise include redevelopment planning and urban design, and leading multi-stakeholder participatory events including charrettes and visioning exercises. Most of his projects integrate concerns for physical and economic redevelopment and involve intense client and community outreach and participation. Projects range in scale from tens of acres (Downtown Dunedin FL) to several hundred square miles (Pinellas by Design).

Moore received his Ph.D. from the University of Pennsylvania, and holds degrees from the Massachusetts Institute of Technology (MIT), including an MS in Real Estate Development. An Associate Professor in the School of Architecture & Community Design at the University of South Florida from 1988 through 2000, he was the Acting Dean of the School during 1999-2000, and also directed the Florida Center for Community Design and Research for five years. While with the Center, he co-authored two elements of the State of Florida's statewide transportation policy; the first addressed the integration of land-use planning and transportation planning; the second described the critical role of mobility in developing integrated and sustainable communities.

Prior to joining HDR, Dr. Moore also served as an urban design and planning consultant to a number of national firms, where he worked on downtown and neighborhood master plans, sustainable development strategies, regional master plans, urban design, infill development, and transit-oriented design.

James Rojas is an urban planner, and artist. He is one of the few nationally recognized urban planners to examine U.S. Latino cultural influences on urban design. His influential thesis on the Latino built environment has been widely cited.

Mr. Rojas founded the Latino Urban Forum (LUF), a volunteer advocacy group, dedicated to understanding and improving the built environment of Los Angeles' Latino communities.

Mr. Rojas developed a process that improves community participation through engagement, creative thinking, celebration, but most importantly raises people's consciousness on the built environment around them and how it impacts their experience of place. It has been highly successful and replicated nationally. He has facilitate over 250 interactive workshops and created over 50 interactive urban diorama across the country with thousands of participants. He has collaborated with municipalities, non-profits, health and educational institutions, museums and galleries to educate the public on urban planning from topics ranging from transportation, economic development, social justice, health and many others.

He was appointed by Governor Howard Dean as the private industry member of Vermont's Municipal Land Law Review Commission (2001-2003), and serves as an advisor to Vermont's current Governor on land use issues.
